- 3. The Consultant /Adviser shall attend the Office during working hours. The Officer shall be eligible for CL and DL as per the rules applicable to the Scientists of KSCSTE and absence from the station may be intimated to the Reporting Officer. The Official shall be eligible for TA and boarding charges while on official tour at par with that of Scientist of KSCSTE. The decision of EVP will be final on such matters.
- 4. Remuneration to the Official shall be decided by the EC and the payment shall be from the budget head of the programme in which he/she is engaged.
- 5. EVP may decide to grant other facilities as permitted by Government for such engagements.

Other Matters.

After completing regular agenda, the members deliberated on various issues pertaining to the management of the Council Headquarters, R&D Centers as well as schemes & programs operated by the Council. The following decisions were taken after the long and intensive deliberations.

- 1. Executive Committee should be briefed about the development of the Council. At least one R&D Center and one division, in rotation, may present a brief report about the progress achieved by the Centre/division during each EC meeting. A monthly status report in well-designed format may be collected from each centre/division which also to be presented by the Member Secretary in each meeting.
- 2. All appointments should be made through a transparent selection process through open advertisement. This is applicable to Permanent, Temporary, contract or any other type of appointments. Under no circumstances a proposal for regularization will be entertained without the due process of Advt:, selection etc.
- 3. Internal Audit: There should be Internal audit report to be ready in every quarter. This report should be studied in detail by the Audit committee constituted for the purpose and their observations to be presented in the EC in a regular manner. The EC also suggested that the Audit Committee may visit the various centers and orient them to follow the procedure required, which was done by the audit committee on earlier occasions..
- 4. When formulating the agenda notes for EC, the following points should also be included.
 - a. Who initiated the proposal?
 - b. Who approved the proposal?.
 - c. Who shall be responsible for action?
- 5. While granting Research schemes to outside agencies, preference shall be given to State institutions. Research proposals from Central institutions can be supported only if the proposal has a collaborator from

a State institution. The infrastructure support provided in the scheme shall invariably be given to the State institution. This may be introduced to all such proposals supported by the Council with immediate effect.

An example of one such case was pointed out and it was decided that any such representations will be reviewed by the committee again for a decision.

6. The plan proposals put forward by the R&D Centers shall be meant for infrastructure development of the Centre. All the proposals should be approved by the Managing Committee and the Executive Committee before submitting the same to the Government.
