Guidelines for organizing World Wetland Day -2015 Celebrations

- Kerala State Council for Science, Technology and Environment (KSCSTE) invites proposals
 for the observance of World Wetland Day-2015 (WWD 2015) from Govt./Aided Colleges,
 University Departments, R&D Centres of the Council and other Research Organizations and
 Govt. Agencies.
- 2. Focal theme selected for WWD 2015 is: "Wetland for our Future"
- 3. The proposals for WWD 2015 will be scrutinized and selection of institutions will be made purely based on merit and fulfilling of guidelines. Since large number of proposals are expected, sufficient number of proposals will be selected based on those proposals received before due date. Hence, the institutions are encouraged to apply as early as possible. The decision of KSCSTE in the selection of institutions shall be final.

4. The extent of financial support from Council will be as below:

- 5. Suggested Activity for WWD 2015 Celebrations:
 - a. Seminars, Symposia
 - b. Thematic Exhibition
 - c. Popular Lecture / Demonstration
 - d. Slide Shows / Film Shows
 - e. Debates/ Competitions
 - f. Filed Oriented activities
- 6. KSCSTE should be duly acknowledged in the programme and 'Supported by Kerala State Council for Science, Technology and Environment' should be written in all the brochures, banners (Only cloth banner to be used), other publicity materials etc.
- 7. Each activity should be documented and detailed report should be sent to Council with captioned photographs (Hard copy) highlighting the impact and suggesting follow up activity.
- 8. Finalized programme schedule and details of the various activities organized in connection with WWD-2015 should be furnished to the Council office.
- 9. The financial assistance will be disbursed to the Head of the Institution, only after the successful conduct of the programme, subject to the submission of satisfactory report and financial statements.
 - i) Principal / Headmaster of schools who have successfully organized the programme should forward the Report and Statement of Expenditure showing the budget heads

along with utilisation certificate, within one month after the conduct of the programme.

- ii) Other Institutions including, R&D Institutions, Govt Agencies etc. should submit audited Statement of Expenditure and Utilization Certificate in the standard format signed by registered Charted Accountant counter signed by the Head of the Institution is accepted within one month after the conduct of the programme.
- Reports received after one month of conduct of the programme will not be considered for financial assistance.
- 10. Proposals in the prescribed format may be submitted at the earliest but not later than 31st December 2014. Incomplete and application without proper documents will not be considered.
