Six Research institutions of the Government of Keala are led by eminent scientists as Directors. Executive Vice President of KSCSTE needs to enjoy credibility as an eminent scientist to be able to command professional respect as provide ledership functions. The job needs abilities to connect resources to causes and science to development of the State. Professional stature, credibility as a scientist, experience in governance related functions dealing with scientific establishments, sensitivity to relate to a variety of stake holders of KSCSTE and financial prudence in investments are needed for success as an Executive Vice President of the Council. A suitable blend of thought leadership of science based professional and maturity of an evidence-based decision making executive is required for the job.

- a) Doctoral degree in any branch of natural sciences including technology and medicine,.
- b) at least 15 years of experience at the level of a professor or its equivalent cadre in the Government of India.

About Kerala State Council for Science, Technology and Environment (KSCSTE): Government of India formed the Ministry of Science and Technology in 1971. Kerala Government constituted a Committee for Science, Technology and Environment in 1972 in order to connect science and technology for speeding up the socio economic development of the State. The committee was later restructured and converted into an autonomous body Kerala state Council for Science, Technology and Environment in November 2002. Motto of the Council is "Science for Humanity". Connecting science and technology to the socio economic development and protection of ecology is the main function of the state council. Government of Kerala is one among the fore runners of state Governments of Republic of India in connecting knowledge to wealth and value creation in preparing for entry into knowledge economy. Recognizing the role and need for scientific temper, the state Government invests liberally into the state Council for promotion of scientific research and technology led development.
