The Kerala State Council for Science, Technology and Environment (KSCSTE) was constituted in November 2002 as an autonomous body under Government of Kerala to promote excellence in science, technology and development with the involvement of academia, industry and research organizations. There are several R & D institutions under the ambit of KSCSTE. In order to keep the R&D institutions in the forefront of their respective expertise and innovations, we are looking for dynamic, result-oriented, top-notch scientist with relevant academic/management experience to be appointed as Director. The Director is the Chief Executive of each institute and is responsible for the management, administration and development of prospective plan for the institution by providing effective leadership. He/She is expected to lead the institution at an international level and should be able to visualize the problems in the respective fields in a global scenario and identify local solutions. **Qualifications:** First Class Master's Degree in Basic Science (Physics/Chemistry Mathematics/ Statistics/ Botany/Zoology) with PhD in the subject concerned.

in academic institutions/industry will also be considered. Experience should be reflected in scientific publications in indexed journals, patents, books etc.

**(2) Director, Institute for Climate Change Studies (KSCSTE-ICCS), Kottayam**

**Essential Qualifications :** PhD in Physical Sciences/Earth Sciences/ Atmospheric Sciences/ Environmental Sciences/ Meteorology/ Oceanography/ Civil Engineering/Mechanical Engineering/ Agricultural Engineering with first class Master's Degree in relevant subject. The topic of the PhD research should be related to Climate Change Studies.

**Experience :** 15 years in a research/academic/R&D institution or organization, of which 10 years should be at a senior level provided that 5 years shall be in the grade of Senior Principal Scientist (PB-Rs.37400-67000, Grade Pay-8900) or shall be presently holding the grade of Chief Scientist (PB-Rs.37400-67000, Grade Pay-10000). Equivalent positions/grades in academic institutions/industry will also be considered.
