## PURCHASE OF FLOWER PLANTS IN CONNECTION WITH KERALEEYAM-2023 dated 03-10-2023

## Keraleeyam 2023- Flower Show, dated 03-10-2023

Government of Kerala is delighted to announce the upcoming "Keraleeyam 2023" festival, (order no. 4073/2023/GAD, Dated, 04-09-2023) scheduled to take place from November 1st to November 7th, 2023, in the vibrant city of Thiruvananthapuram. In connection with this event, government proposed to schedule flower show and floral installations at various identified locations and venues in Thiruvananthapuram. In light of this exciting flower show program, Member Secretary, Kerala State Council for Science, technology and environment (KSCSTE) invites Expression of Interest (EOI) for purchase of flower plants from reputed Nurseries/gardens/agencies/organizations/firms/individuals with proven track record for good and quality flower sellers/dealers at the state/the national level.

Eligible and interested reputed organizations/individuals are requested to submit their EOI under limited tender mode for the purchase of flower plants as part of Keraleeyam '23, spanning from November 1<sup>st</sup> to November 7<sup>th</sup>, 2023.

Your scope of work and guidelines for this purchase encompasses the following responsibilities:

#### Scope of the Work

- 1) The name of varieties of plants and orchids are separately given in Annexure 1.
- 2) Total number of plants listed in **Table 1** to be purchased will be 25,000 30,000 Nos. and listed flowers in **Table 2** (Orchids) will be about 500 Nos. required.
- 3) The size of the pots should be either 6" (Six inch) or 8" (eight inch) and provide the financial estimate for both the size.
- 4) The total number of plants will be decided and selected by the Tenderer based on the financial estimate given by the bidder.
- 5) Plants must be in flowering with 30% open flowers and 70 % in bud for Plants given in **Table 1** and Plants must be in flowering with 80% open flowers and 20 % in bud for Orchids varieties (**Table 2**).
- 6) All plants must be in good health and disease free.
- 7) At the delivery point the plants must be healthy and handover to tenderer without any damage.
- 8) Maximum varieties/ colours must be included in each group.
- 9) The rates quoted must include the transporting charges.

- 10) Plants should deliver at **Kanakakunnu Palace compound, Thiruvananthapuram,** Kerala before **5 PM on 29th October 2023.**
- 11) **Along with the price, photos of the plants** should also be included in the proposal.
- 12) The applicants are requested to submit detailed proposal along with the financial estimate as per the format (Annexure I) in the email ID <u>keraleeyamflowershow@gmail.com</u>.

### Guidelines of the Work

- 1. Selected organization/individual should adhere to the guidance and directives provided by this EOI and Convenor of the Flower show Committee in accordance with government orders for the Keraleeyam '23 flower show.
- 2. Poly bags will not be permitted.
- 3. The selected agency/individual should follow the pot measurement and health and quality of flower plants specified in this EOI.
- 4. Agency is responsible for all the risk and cost associated with the entire sale and will ensure its timely deliver the items before the proposed date.
- 5. Be prepared to accommodate any additional scope of work as directed by the committee
- 6. Obtain all necessary clearances and approvals from relevant government departments and ensure timely inspections if any required.
- 7. The only those attending the pre-bid meeting will be eligible for attending the final selection process. Based on the information shared in the pre-bid meeting, interested participants are required to submit a proposal with financial estimate.
- 8. The evaluation and selection criteria of the agency/individual will be based on the quality-cum-lowest tender, L1.
- 9. The competent authority of Flower show committee reserves the right to accept or reject any applications and to annul the process and reject all applications at any time, without assigning any reason or incurring any liability to the Applicant.
- 10. Kindly Submit your Expression of Interest in time to avoid delay, there will not be extension of date.

### Important Dates to Remember:

- 1. Application submission period: Opens on October 4, 2023, and runs for 7 days.
- 2. Online Pre-bid Meeting will be Scheduled on **October 7th, 15:00 hrs** (the Meeting link will be published on KSCSTE website, <u>www.kscste.kerala.gov.in</u>. or communicate back to the responded bidders.
- 3. Application deadline: Closes on **October 11th, 2023**, 15.00 hrs with evaluation taking place on October 12th, 2023.
