1. The scheme is constituted for the purpose of providing assistance in the form of scholarships to students for pursuing higher studies in Basic or Natural Science in any of the Institutions/Universities in India.
2. Students selected for the award of Prathibha Scholarship shall be provided scholarship as follows, subject to the renewal norms of the Scheme.

Second Year PG <i>or</i> First Year PG (For students enrolled in UG(Hons)) <i>or</i> 5th year Integrated PG	Rs. 60,000/-

3. The Course of study should be continuous and no break is allowed in between. In the event of discontinuance of the Course by the student, the matter should be informed to KSCSTE through a letter signed by the student and forwarded by the Head of the institution within 15 working days of discontinuation of the Course.
4. Renewal of scholarship for 2nd and 3rd year U.G/Integrated P.G and 2nd year P.G/5th year Integrated P.G is subject to scoring minimum credit requirement as per the curriculum and credit framework specified by University Grants Commission in the National Education Policy-2020 (https://www.ugc.gov.in/pdfnews/7193743_FYUGP.pdf) for the previous year of the course and submission of Mark lists of previous year along with Renewal Data-sheet duly signed.
5. Continuation of scholarship for 4th year UGC (Hons)/P.G Course/4th year Integrated P.G course is subject to scoring minimum credit requirement as per the curriculum and credit framework specified by University Grants Commission in the National Education Policy-2020 (https://www.ugc.gov.in/pdfnews/7193743_FYUGP.pdf) and submission of (i) Consolidated Mark list of U.G programme /Mark lists of all previous 3-years of Integrated Course (ii) Renewal Data-sheet duly signed
6. Students who are **in receipt of/selected for** any other scholarship are not eligible to apply for/avail Prathibha Scholarship. In case Prathibha scholarship awardees receive any other scholarship amount at a later stage, they should refund the entire amount of Prathibha Scholarship received by them. The Head of the Institution is requested to ensure that students who are awarded Prathibha Scholarship are not availing other scholarships additionally for the same Course of study.
7. KSCSTE reserves the right to modify the guidelines of the Prathibha Scholarship Scheme as and when necessary and the Prathibha Scholar is bound to adhere to the Guidelines and the amendments during the tenure of scholarship.
8. KSCSTE reserves the right to use its discretionary powers for taking appropriate decision in case of disputes regarding the award of the Scholarship. In such cases decision of KSCSTE will be final and binding on the candidate.
9. If at any time it is found that the details furnished by the student is against facts or not conforming to the guidelines of the scheme, the scholarship will be cancelled with immediate effect and steps shall be initiated against such students for reimbursing the amount of scholarship.
